The Council will discuss and vote on moving the October EERMC monthly meeting to earlier in the month. This change would be necessary for National Grid to file a joint Three-Year and Annual plan to the Public Utilities Commission by Oct. 15th. OER proposes Oct 8th for the new October meeting date.
