The Review Committee, comprised of Joe Garlick, Bill Riccio, and Bob White, voting members of the Energy Efficiency and Resources Management Council (EERMC), reviewed the two (2) proposals received by the Energy Efficiency and Resource Management Council (EERMC) on August 24, 2020 for the subject EERMC-2020-02 – Legal Services. The valuation was based on the following criteria: 1. Overview and Work Plan (35 points), 2. Qualifications and Experience (25 Points), 3. Project Management and Organization (10 points), 5. ISBE proposal (6 points), and 6. Cost proposal (30 points).

Based on the review of the proposals submitted, the Review Committee believes that the Desautel Law proposal offers all the components that this requisition specifies with a reasonable price and ISBE proposal for the Council. The proposal from Olenn & Penza did not receive an average technical score greater than the required 60 out of 70 technical points. Therefore, the cost and ISBE proposals for Olenn & Penza were not opened, and the Olenn & Penza proposal was deemed not technically qualified.

The Review Committee proposes that the contract with Desautel Law be limited to one (1) year from the contract start date with the option to renew the contract for up to two (2) additional, twelve (12) month periods depending on vendor performance (maximum three (3) year contract length). The contract should be limited to the hourly rates included in the proposal. The Review Committee also encourages the Council to accept the workplan as submitted by Desautel Law on 8/24/2020 as the basis of the contract.
