

Electric Performance




Electric portfolio lifetime savings through May is 7.2% below performance required to meet goals. Electric spending is on pace to meet planned budget.

Year-to-Date Spending Electric Portfolio Total




Gas Performance



RIE Highlights & Key Drivers

- We are outperforming where we were in May last year
 - 95,500 LT MWh (2024) vs. 67,000 LT MWh (2023)
- Retrofit projects accounting for majority of savings
- New Construction projects expected to drive increases (107 active)
- Main Street campaigns completed in Providence and Pawtucket, resulting in 100+ audits scheduled
- Small Business leveraging RI Rebounds funding




Year-to-Date Lifetime Savings C&I Sector Total

RIE Highlights & Key Drivers

- Transition to new tracking system impacting savings
- Retrofit program developments
 - Commissioning data review led to savings reduction
 - Gap closure initiatives: Summer Steam Trap Initiative, Heat Exchanger Initiative
- Holding webinars to increase engagement
- New Construction projects expected to drive savings increases as projects are paid



RIE Highlights & Key Drivers

- IES Single Family continues to progress towards target at healthy rate
 - Significant number of projects not reflected in savings; inputs cut off May 15th
- Westbay CAP now coordinating appliance program – 5 local vendors subscribed
- CAPs continue to overperform on heating system replacements using Department of Human Services (DHS) funding




Year-to-Date Lifetime Savings Income Eligible Sector Total



- HVAC program developments
 - Expect sector savings increase as invoices are processed
 - Conducting extensive outreach including collaboration with OER
- DPA Update: BlocPower
 - Contract finalized in June and offering to be launched in the Fall
 - Presents opportunity to address upfront cost barriers for Multifamily Program




Gas Residential Performance





Electric Income Eligible Performance






Gas Income Eligible Performance
