

Market Potential Study

Market Potential Study (MPS)



Council expected to develop its next set of Three-Year Targets by March of 2026 to inform the 2027-2029 Period

- Targets are typically informed by an MPS

Council's last Market Potential Study covered period of 2021-2026

If Council would like a new MPS to inform its 2027-2029 Targets, it should consider allocating some amount of funding in 2025

- Timeline to complete an MPS is 6-12 months
- Costs are typically in the range of \$300-600k

Allocating time at Council's October Learning, Education, and Advancement Discussion (LEAD) meeting to learn more about this topic and discuss potential for allocating funding in 2025

Option: Allocate remaining difference between Council's statutory maximum and current 2025 Budget Proposal to MPS

- As of 2nd draft of RIE's 2025 Plan, would likely be in the range of \$200k

Council is closely monitoring its spending throughout year to ensure it is managing within the PUC approved amount

URI Public Education Event Planning & Outreach Proposal – *"Efficiency for All"*



 Extension & expansion of current contract with URI Cooperative Extension's Energy Literacy Initiative

 URI would utilize additional funds from another source to support this work

Task 1 (\$70,250) – Community of Practice

- Convene & facilitate *"Efficient Housing for All"* Community of Practice (CoP)
- Design & deploy educational training tool informed by CoP
- Develop pilot Energy Coach Program targeting income eligible customers
- Coordinate with related efforts & entities to maximize collective impact

Task 2 (\$21,000) – Energy Lecture Series

- Plan, host & evaluate three fall lectures themed around "Efficiency for All"
- Provide venue for information sharing & discussion among academic community, industry professionals & public

Total Proposal = \$91,250

- Request that Rhode Island Builders Association itemize how \$40k has been used in the past and identify what could be maintained at \$20k

EE & Climate Awareness Campaign

- Education Committee recommendation to reduce budget by \$10k
- Fund at \$75k for continued work

EEC Website

 Increase to account for higher costs of maintaining site

Printing

 Decrease to cover printing of executive summary pamphlet only

Consultant Services

 Decrease by \$100k to account for lower than planned spending, particularly for EE Implementation RFP support



2022 – Two K-12 contracts were implemented; Educational videos were developed


2023 – \$30k brand initiative not included in public education category






