PURPOSE OF BRIEFING MEMO

The purpose of this briefing memo is to assist Councilors with digesting the many materials and decisions they may need to make at each meeting. It follows a similar format to the official meeting agenda so Councilors can follow along throughout the meeting. For each agenda item, this memo will highlight key considerations for the Council and clearly indicate what actions (if any) the Council needs to take. The Consultant Team (C-Team) has worked with the Office of Energy Resources (OER) to also incorporate the content that Councilors are used to seeing in the "Recommended Vote Language" document. This ensures the Council has a single point of reference during meetings. This memo will also note any supplemental materials that are provided, but not associated with, specific agenda items. The C-Team and OER welcome any feedback on the format and content.

6. COUNCIL BUSINESS

6A. DISCUSSION AND POTENTIAL VOTE TO LAUNCH ENERGY EFFICIENCY AND CLIMATE PUBLIC AWARENESS CAMPAIGN

Key Considerations

- PivotPath's presentation will cover visual display ads, media plan, landing page, and key performance indicators.
- The Project Management Team and the Education Committee have been working with PivotPath since April to identify and refine objectives, target audiences, key messages, calls to action, creative concepts, landing page copy, KPIs, and a media plan.
- The campaign will run from October through December 2024 and include visual and audio ads targeting low- and low-to-moderate income Rhode Islanders.
- The Council has approved \$75,000 in the 2025 budget for continued marketing work, either via a contract extension with PivotPath, or by going out to bid to consider other vendors.

- Are there any adjustments that *must* be made for the Council to feel comfortable launching the campaign?

- strong statement of the Council's concerns, which may be mentioned in the Plan Docket.
- 3. Not endorse the 2025 Plan but indicate that if specific condition(s) are met it would be
- endorsed.
- 4. Not endorse the 2025 Plan and provide a list of reasons why it was not endorsed for PUC
- consideration in its final review of the 2025 Plan.

7B. CONSULTANT TEAM PRESENTATION ON THE COST-EFFECTIVENESS REPORT FOR THE 2025 ANNUAL ENERGY EFFICIENCY PLAN

Key Considerations

- Least Cost Procurement Standards require that the Council submit a report on its assessment of the cost-effectiveness of the 2025 Annual Plan
- The report must be filed within three weeks of the Plan filing
- The C-Team will prepare this report for consideration by the Council at the October meeting,
 which will fall within the three-week deadline
