- Cross-examination of the Company and the Council, primarily from the Commission and the Division
- Commission held an Open Meeting where they discussed findings from the hearings and rule on the 2025 EE Plan, including the Council's budget on December 19th
 - Note This meeting was held on the same date as the Council meeting and early takeaways will be shared with Councilors with a full write up coming in 2025

8C. REVIEW AND POTENTIAL VOTE ON CONSULTANT SERVICES CONTRACT EXTENSION

Key Considerations

- The Council's current agreement with Optimal Energy began in 2021 after a competitive solicitation.
- In 2022, the Council chose to pursue the first of two two-year contract extensions with the existing consultant services to cover calendar years 2023-2024.
- The Council may elect to execute one final contract extension with their current consultant services for an additional two years of service, or may choose to go out to bid for new consultant services for 2025 and beyond.
- This would be the final extension under the current agreement terms and if the extension is executed, the Council should plan to go out to bid for these services again in 2026.

Discussion Questions

- Has the Council's consultant services met its expectations to support the Council in its review and oversight of the energy efficiency programs and initiatives administered by the electric and gas distribution company?
- Are the Council's consultant services being provided cost-effectively?
- Are there adjustments to consultant services that the Council would like to see?

Recommended Vote Language

- A motion to execute an extension of the existing EEC consultant team: A motion to execute the second of the EEC's two (2) twenty-four-month extensions of the existing EEC Consultant Team contract and to direct the Office of Energy Resources (OER) to work with EEC Legal Counsel to execute the contract extension documents.
- A motion to approve going to the market for consultant services: A motion to approve issuing a request for proposals (RFP) to solicit consultant services for the EEC and to direct the Office of Energy Resources to prepare a draft in advance of the December Council meeting for consideration.

SUPPLEMENTAL MATERIALS

MONTHLY DATA SNAPSHOT

The Company's process for transitioning from its legacy data-reporting systems to its new one is continuing to take longer than initially expected. The C-Team will begin distributing Monthly Data Snapshots to the Councilors again as soon as possible once the Company's data reporting system transition is complete.

COUNCIL BUDGET TRACKER

OER will provide an updated version of the Council's budget tracker.
