Efficient Housing for All Community of Practice (EHACoP)

1. Defining the EHACoP

1.1 Mission & Purpose

The Efficient Housing for All Community of Practice (EHACoP) will be a structured, multi-stakeholder initiative that fosters cross-sector collaboration among specialists in public health, community engagement, and energy efficiency. The Community of Practice (CoP) will serve as a knowledge-sharing and action-oriented network that identifies challenges, co-develops solutions, and enhances program implementation through cross-sector partnerships. Its primary objective is to mitigate barriers to participation in income-eligible home energy efficiency programs in Rhode Island through evidence-based, community-driven interventions.

This model aligns with the CoP model as described in Wenger-Trayner et al. (2015), which defines a CoP as a group of people who share a concern and learn how to address it through regular interaction [3]. The EHACoP will build on best practices in strategic convening and collaborative learning from other CoPs in public health and energy equity [1,2].

1.2 Goals

- 1. **Increase Participation:** Develop and deploy community engagement strategies to reduce barriers preventing income-eligible households from accessing energy efficiency programs.
- 2. **Enhance Cross-Sector Collaboration:** Establish an active network between energy efficiency experts, public health advocates, community organizations, and residents to co-develop solutions.
- 3. **Improve Program Design:** Provide recommendations to policymakers and program administrators for more accessible, effective, and equitable energy efficiency initiatives.
- 4. **Develop Knowledge-Sharing Mechanisms:** Create a centralized repository of resources, best practices, and case studies for stakeholders and community members [6].
- 5. **Measure and Communicate Impact:** Utilize evaluation models to track progress, identify key challenges, and refine approaches [4].

2. Structuring the EHACoP

2.1 Membership & Stakeholders

EHACoP will include the following members and roles:

- Core Institutional Partners: Organizations and agencies directly involved in the facilitation of the CoP and/or the implementation of energy efficiency programming in Rhode Island.
 - URI Cooperative Extension Energy Literacy Initiative
 - RI Department of Health (RIDOH) Health Equity Zone (HEZ)
 - RI Office of Energy Resources (RIOER)
 - RI Department of Human Services (RIDHS)
 - RI Community Action Agencies (CAA)
 - RI Energy
 - ClearResult
 - The RISE Group
 - Local municipal authorities and housing organizations
- Community Representatives: Residents with lived experience, community health workers, and advocates, recruited through HEZ partnerships.
 - Income-eligible residents with lived experience of energy insecurity;
 - o Community-based health professionals and grassroots advocates; and
 - Tenant advocacy groups and property management entities.
- Advisory Partners: Policymakers, energy efficiency program administrators, and funders who can
 influence programmatic and policy changes and provide strategic direction and review of EHACoP
 findings.
 - o RI Energy Efficiency Council (EEC) members
 - RI Office of Energy Resources (RIOER) staff
 - State legislative committees overseeing energy and housing policy
- Academic & Research Support: Universities and research institutions contributing data analysis, behavioral research, and best practices [5].
 - University of Rhode Island
 - Brown University
 - Nonprofits engaged in energy equity and public health research

2.2 Roles & Responsibilities

- Facilitators (URI & EEC Team):
 - Kate Hardesty, Kevin Drumm
 - Oversee CoP activities, Facilitate meetings, Ensure strategic alignment, Reporting
 - Nina Lima
 - Coordination of notetakers, materials management, participant registration
- Knowledge Managers (URI & EEC Team):
 - Document discussions
 - Curate resources
 - Disseminate findings via a public knowledge-sharing platform [5].
- Working Groups (Thematic Teams):
 - Address specific barriers such as outreach, deferral issues, program accessibility, and health-energy linkages [3].
- Community Ambassadors:
 - Residents and frontline workers who provide real-world perspectives and ensure culturally relevant engagement strategies.

3. Operational Framework

3.1 Convening & Engagement Model

EHACoP will adopt a multi-tiered engagement structure informed by the Rockefeller Foundation's strategic convening framework [2]. EHACoP will use a combination of regular gatherings to promote knowledge exchange and action:

- Monthly Meetings: Led by URI Cooperative Extension Team, half of the meetings will be virtual on Zoom and half will be in-person, hosted at community libraries or nonprofits. The meetings will involve the presentation of relevant information and facilitated discussions focused on emerging barriers and solutions.
- Working Group Breakouts: Beginning in Session 4, dive into specific challenges/barriers (e.g. incentivizing landlords to weatherize their homes or addressing lead and mold remediation barriers to weatherization) identified during Sessions 1-3 in groups.
- Community Learning Events: Follow-up to the CoP conversation sessions, these events are an
 opportunity for public engagement and knowledge dissemination. These could include the RIDOH
 Health Equity Zone Learning Community Events and the Plugged into Energy Research lecture series,
 for example.

Action Steps for Effective Convening:

- 1. **Pre-meeting preparation:** Agenda-setting based on member surveys, logistical coordination, and pre-distributed materials.
- 2. **Facilitated discussion format:** Use interactive workshops, small-group breakouts, and problem-solving exercises [2].
- 3. **Real-time documentation & feedback:** Live note-taking and post-meeting synthesis for accountability; incorporate a "safebox" list of agreed upon discussion items / findings at the end of each session.
- 4. Follow-up and accountability: Clear action items assigned and tracked over time.

3.2 Community Learning & Capacity Building

EHACoP will employ structured learning models from previous successful CoPs [6]:

- Workshops & Webinars: Training on energy efficiency, indoor air quality, and overcoming programmatic barriers.
- **Knowledge Repository:** A digital platform housing case studies, outreach materials, and policy briefs [5].
- Storytelling & Lived Experience Integration: Collecting and publishing resident narratives to inform future policy changes with support from Community Action Agencies, Health Equity Zones, the RI Energy Efficiency Council, ClearResult and The RISE Group [3].

3.3 Communication & Outreach

- Targeted outreach campaigns using community radio, flyers, social media, and HEZ/CAA networks.
- Multilingual materials in Spanish, Portuguese, and other languages relevant to Rhode Island communities.
- Regular updates (email communications, newsletters, reports) summarizing meeting takeaways, progress, and success stories [5].

3.4 Adaptive Learning & Continuous Improvement

- Regular reflection sessions to refine strategies.
- Data-driven adjustments based on survey findings and participation trends.
- Regular meetings with the advisory committee between CoP sessions.
 - Sessions will be held:
 - During EEC Education Committee meetings
 - Week of May 26
 - Week of July 7

4. Strategy Development & Action Planning

4.1 SOAR Framework Application

Using the SOAR (Strengths, Opportunities, Aspirations, Results) framework, EHACoP will identify strategic priorities [1]:

- Strengths: Leveraging existing HEZ and CAA networks for income eligible community engagement.
- **Opportunities:** Expand participation and reduce deferrals through integrated service models and direct targeting of solutions to pre-weatherization barriers.
- Aspirations: Ensure all income-eligible residents benefit from energy efficiency programs.
- Results: Tracking of increased enrollment rates and reduced deferral cases with data from RI Energy, the RISE Group, ClearResult and CAA weatherization, etc.

5. Evaluation & Sustainability

5.1 Monitoring & Evaluation

Building on evaluation models for CoPs [4], EHACoP will track:

- 1. **Short-Term Actions (0-6 months)**: Convene community members to identify and prioritize barriers and develop proposed solutions to the prioritized barriers.
 - a. Participation Metrics: Attendance at convenings, diversity of membership.
 - b. **Engagement Outcomes:** Changes in knowledge, collaboration, and participation, measured through: a) Pre- and post-event surveys; b) Stakeholder interviews and qualitative impact assessment; c) Tracking new partnerships and initiatives launched; and d) Case studies documenting participation barriers & solutions [4].
 - c. **Programmatic Impact:** Increase in a) EHACoP participants' weatherization completion (e.g. Leading by Example); and b) general income eligible weatherization completion rate [6].
 - d. **Community Outreach:** Number of community members engaged by CoP participants as part of CoP homework assignments
- 2. Mid-Term Goals (6-12 months): Advocate for policy improvements based on CoP recommendations.
 - a. **Policy Influence:** Number of recommendations adopted by state and utility partners [3].
- 3. **Long-Term Vision (3+ years)**: Institutionalize CoP recommendations into statewide energy efficiency policies. *NOTE: This is external / beyond the scope of this particular effort.*

5.2 Outputs

5.2.1 Policy Recommendations

- Provide policy recommendations to the Energy Efficiency Council to inform and be shared with relevant stakeholders and changemakers.
- Strategies for ensuring that recommendations are achieved
 - Institutional Support: Ensure short- and long term commitment from the RI Office of Energy Resources and the RI Energy Efficiency Council, RI Energy and other funders to follow through with solutions proposed through the EHACoP process [2].
 - Institutional Capacity Building: Embed CoP recommendations into permanent policy structures. [3].

5.2.2 RI Energy Efficiency Roadmap

- Compilation of a **comprehensive list of available state- and municipal-level resources** for energy efficiency upgrades and the reconciliation of pre-weatherization barriers.
- Creation of an **energy efficiency roadmap** to assist RI residents in navigating energy efficiency and pre-weatherization programs.
- To ensure sustainability of this output, the roadmap will need to be continuously updated with input from relevant stakeholders. On the website where the roadmap is hosted, a form will enable stakeholders to submit updates periodically.

5.2.3 Process Replication Guide

• Scalability assessments to share our process to be replicated for other topics or in other states.

6. Conclusion

The EHACoP is designed to reduce barriers to energy efficiency for income-eligible Rhode Islanders. Through strategic convening, knowledge-sharing, and advocacy, it will drive measurable improvements in participation rates and program accessibility. By leveraging best practices from established CoPs, the EHACoP will serve as a national model for energy equity and public health collaboration.
