# PURPOSE OF BRIEFING MEMO

The purpose of this briefing memo is to assist members of the Energy Efficiency Council<sup>1</sup> with digesting the many materials and decisions they may need to make at each meeting. It follows a similar format to the meeting agenda so Councilors can follow along throughout the meeting. For each agenda item, this memo will highlight key considerations for the Council and clearly indicate what actions (if any) the Council needs to take. The Consultant Team (C-Team) has worked with the Office of Energy Resources (OER) to also incorporate the content that Councilors are used to seeing in the "Recommended Vote Language" document. This ensures the Council has a single point of reference during meetings. This memo will also note any supplemental materials that are provided, but not associated with, specific agenda items. The C-Team and OER welcome any feedback on the format and content.

#### 6A. PRESENTATION AND DISCUSSION OF 2024 END-OF-YEAR PROGRAM PERFORMANCE

#### **Key Considerations**

- The C-Team and the Company will present on 2024 program performance. The Company's Year-End Report will also be included as a meeting material.
- The C-Team's content includes portfolio-level summaries on savings performance, spending, cost-to-achieve, performance incentives, benefits, emissions reductions, and savings performance by program. It also includes a couple of select program highlights.
- The Company's content will highlight key drivers of performance, particularly for programs that underachieved in 2024. It also includes some additional highlights for programs that did well in 2024.
- A high-level key takeaway slide is provided for quick reference (see slide 4).

#### **Discussion Questions**

- What are some lessons learned from programs in 2024 that can be acted on in implementing 2025 programs and planning for 2026 and beyond?
- What measures and/or programs have opportunity for growth?

# 6B. RHODE ISLAND ENERGY PRESENTATION ON THE 2026 DRAFT PLAN NARRATIVE

#### Key Considerations

- Rhode Island Energy distributed the first draft of the 2026 Annual Energy Efficiency Plan (narrative and numbers) on Friday June 20<sup>th</sup>.
- The Company will update the Council on the Plan's development timeline, key program updates being proposed for 2026, as well as an overview of the first draft budget numbers
- High-level electric and gas portfolio savings and budget numbers indicate significant decrease in budgets and savings.
  - Electric Portfolio: Proposed savings are down 33% compared to the 2025 Plan, and proposed budgets are down 16% compared to the 2025 Plan
  - **Gas Portfolio:** Proposed savings are down 2% compared to the 2025 Plan, and proposed budgets are down 9% compared to the 2025 Plan
