PURPOSE OF BRIEFING MEMO

6. PROGRAM OVERSIGHT

6A. CONSULTANT TEAM PRESENTATION AND DICSUSSION ON THE COUNCIL'S OPTIONS FOR ENDORSING THE PLAN

Key Considerations

- This brief presentation is intended to ensure the Council is aware of its role and responsibilities
 with respect to voting on Rhode Island Energy's 2026 Energy Efficiency Plan prior to
 presentations from Rhode Island Energy and the C-Team on this matter.

6D. COUNCIL DISCUSSION AND VOTE ON THE 2026 ANNUAL ENERGY EFFICIENCY PLAN

Key Considerations

- Rhode Island Energy and the C-Team have presented on the final draft of the 2026 Plan, with key considerations for the Council vote highlighted
- The Council must vote whether or not to endorse the Plan (see vote options listed below)
- The Council may raise outstanding concerns through a variety of methods in the 2026 EE Plan Docket after the Plan is field with the PUC

Discussion Questions

- What aspects of the Plan does the Council still have concerns with?
- How would the Council like to raise outstanding concerns in the Docket for the Plan?
- Are there concerns the Council has but feels are best to be addressed through future collaboration with the Company as opposed to raising directly in the Docket?
- Do Councilors have any questions regarding regulatory review of the 2026 Annual Plan and/or any Council filings in the docket?

Recommended Vote Language

- 1. Endorse the 2026 Plan and join a Settlement of the Parties: A motion to endorse the 2026 Energy Efficiency Plan as presented by Rhode Island Energy to the Council on September 25, 2025, allowing for non-substantive changes (typos, etc.) to be done prior to filing.
 - Furthermore, the Council directs its legal Counsel to provide a signature page indicating the Council is a settling party to Rhode Island Energy prior to the October 1st filing deadline.
- 2. **Endorse the 2026 Plan and decline to join a Settlement of the Parties:** A motion to endorse the 2026 Energy Efficiency Plan as presented by Rhode Island Energy to the Council on September 25, 2025, allowing for non-substantive changes (typos, etc.) to be done prior to filing.
- 3. **Not endorse the 2026 Plan with conditions that would lead to an endorsement:** A motion to not endorse, at this time, the 2026 Energy Efficiency Plan as presented by Rhode Island Energy

to the Council on September 25, 2025. The Council would change its vote to an endorsement of the 2026 Plan should it meet the following condition(s): {state condition(s)}

4. **Not endorse the 2026 Plan:** A motion to not endorse, at this time, the 2026 Energy Efficiency Plan as presented by Rhode Island Energy to the Council on September 25, 2025.

Furthermore, the Council directs its Consultant Team and legal counsel to document the Council's reasons for not endorsing and to submit those to the PUC for its consideration in final review of the 2026 Energy Efficiency Plan.

6E. PRESENTATION ON THE COST-EFFECTIVENESS REPORT FOR THE 2026 ANNUAL ENERGY EFFICIENCY PLAN

Key Considerations

- Least Cost Procurement Standards require that the Council submit a report on its assessment of the cost-effectiveness of the 2026 Annual Plan
- The report must be filed within three weeks of the Plan filing
- The C-Team will prepare this report for consideration by the Council at the October meeting, which will fall within the three-week deadline

- Are there any changes to the report that the C-Team is contemplating compared to prior iterations?
- Does the Council's vote on the 2026 Plan impact any of the content included in the costeffectiveness report?

7. COUNCIL BUSINESS

7A. PRESENTATION AND DISCUSSION ON SETTING 2027-2029 ENERGY EFFICIENCY TARGETS

Key Considerations

- The Council is required to develop and submit to the PUC energy efficiency program targets for the period of 2027-2029
- The purpose of the targets is to help establish what is potentially available cost-effective efficiency and to guide establishment of savings goals

• Targets historically have utilized potential study results for the corresponding years. Since the most recent study only goes through 2026, the Council will need to identify resources and a potential approach for ensuring it is able to develop its proposed targets for 2027-2029.

Discussion Questions

- Of the report components that are optional, are there any that the Council would like to include as part of this work?
- How should the Council balance benefits of setting aggressive targets with risks of overestimating market readiness or budget capacity?
- How should other policy/priorities be considered (e.g., equity and access, integration with Act on Climate, etc.)?
