# **Contract Status and Options**

### **Consultant Services**



- Technical consultant services provided by Optimal Energy (an NV5 company)
- Current agreement with Optimal began in 2021
- At the December 2024 Council meeting, The Council voted to execute a 2-year extension with Optimal for 2025-2026, which is the final extension allowed under the current agreement
- Council should plan to go out to bid for these services in 2026 to have services in place for 2027

## **Legal Services**



- Legal services provided by Handy Law, LLC
- Current agreement began April 2024 for one year until end of April 2025 and was extended through April 2026
- Council has the option to extend this agreement for 1 additional 1-year term

- Would the Council like to extend current services for another year?
- Alternative would be to issue a new RFP for legal services

### **Community of Practice and Lecture Series**



- Public education activities agreement in place with the University of Rhode Island Cooperative Extension
- Current agreement with URI began February 2023, and was extended through April 2026
- The Council has an option to renew this agreement
- Public Forum has evolved over the past few years as the URI team created an "Efficient Housing for All Community of Practice" in 2025 to convene stakeholders on residential energy efficiency and meet stakeholders where they are
- URI has prepared a program proposal for 2026
